

User Consent and Indemnity Form

CONSENT TO PROCESS PERSONAL INFORMATION

When you provide the Company with personal information about yourself

The User understands and warrants that:

- by providing the Company with Personal Information, the User consents to disclose such information to the Company and for the Company to disclose the Personal Information to Advertisers in terms of its Privacy Policy; and
- the User consents to providing its Personal Information and it has been explained to the User (in the Privacy Policy) how the Company will collect, use, disclose and retain the User's personal information.

Type of information processed by the Company

- Identifying information – such as full names, ID number or passport number, date of birth;
- Ethnic information - such as race and gender;
- Contact information – such as phone number, email address, physical address; and
- Survey information – such as views, opinions, personal preferences and other personal information you voluntarily choose to provide us and/or our Advertisers in the relevant surveys, forms or questionnaires.

How the Company will collect this information

- Information is collected directly from the User when:
 - signing up on www.sebenza.taxi (“the Platform”) and consuming marketing content, adverts and media on the Platform;
 - answering surveys, forms and questionnaires concerning products, services, interests, views and personal preferences;
 - entering competitions, giveaways, and promotions or enquiring about our Advertisers' offerings;
- An electronic copy of this form will be made available on request and shall be available for as long as you use our services, or until such time as you withdraw your consent.

Legal basis and purpose for processing this information

The Company relies upon the User's consent to process the below information for the following purposes (where appropriate the Company may also rely on its legitimate interests explained in the Privacy Policy).

- Identifying and contact information is processed by the Company to verify the identity the contractual party and may be used to enforce or defend the Company's legal rights in relation to such services.
- Ethnic information is processed for statistics, analytics and market research purposes with your specific consent in terms of this form.
- Survey information is processed for marketing and analytical purposes detailed in our Privacy Policy with your specific consent to do so.

Sharing, Sale and Security of this information

- Personal Information is shared and disclosed to Advertisers (the Company's Client's) as detailed in the Privacy Policy on the Platform.
- Personal Information is sold to the Company's Client's so that we are able to provide Users with access to the internet and fund our infrastructure. Our interest in sharing this information is explained further in the Privacy Policy.
- The Company makes use of firewalls, encryption, passwords, anti-virus and various other security measures concerning personal information which are fully described in the Privacy Policy.

Voluntary collection

Whilst it is voluntary to provide the Company with this information (i.e. the User may choose not to use the Platform), the Company will likely be unable to allow the User access to or use of the Platform. If the User does not consent (or later withdraws its consent), the Company will have the right, at its sole discretion, to terminate the services provided.

Withdrawal of Consent and how to access your Data Protection Rights

The User is aware that:

- it has the right to withdraw its consent at any time by informing the Company that it wishes to do so by completing the appropriate Withdrawal of Consent Form. The User is also entitled to object to the processing of its personal information and to obtain a copy of its personal information at any time;
- the User's further rights are explained in detail in the Company's Privacy Policy, which the User confirms having read and understood.
